CERTIFICATE OF INSURANCE REQUIRED

DEADLINE: January 15, 2010

As an exhibitor, you are required to carry workmen's compensation and commercial general liability which includes contractors, personal injury and blanket contractual liability insurance at limits of at least \$1,000,000 per occurrence, \$2,000,000 aggregate. This coverage must be evidenced by a Certificate of Insurance (see enclosed sample) with a 30-day notice of cancellation provision to the holder and supplied to and naming Bobit Business Media, CAR Conference, Caesars Palace and Freeman Decorating as additional insurers at least 30 days before the first day of move-in.

A Certificate of Insurance may be obtained through your primary Insurance Agency, or you may be able to obtain a rider's policy on your homeowner's insurance, business/commercial or auto insurance. Exhibitors not already covered by an insurance carrier can view the CAR website for an online list of insurance companies to contact for show coverage.
